This Order is made by the Kent County Council ("the Authority") under 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that map sheet 175 (TR34SE) of the Definitive Map and Statement for the County of Kent requires modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) the discovery of evidence by the Authority which shows that a right of way which is not shown in the map and statement subsists, or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path or a restricted byway or, subject to section 54A, a Byway Open to All Traffic.

The Authority has consulted with every local authority whose area includes the land to which the Order relates.

The Kent County Council hereby orders that:

- 1. For the purpose of this Order the relevant date is 1st October 2025.
- 2. Sheet 175 (TR34SE) of the Definitive Map for the County of Kent and its associated Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to this Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as "The Kent County Council (Public Footpath ER308 at St Margarets at Cliffe) Definitive Map Modification Order 2025".

Description of path to be added

The effect of this Order is to add a public footpath numbered ER308, with a width of 2.5 metres, which commences at its junction with public footpath ER28 at NGR TR 3632 4485 (Point A) and travels in a generally south southwesterly direction for approximately 150 metres to its connection with Public Footpath ER276 (Droveway Gardens) at NGR TR 3624 4472 (Point B). As shown on the Order plan between the points A-B.
