THE PARISH COUNCIL OF ST MARGARETS-AT-CLIFFE

Minutes of the Annual Meeting of the above Parish Council held on Monday 8th May 2017 in St Margarets Hall, Reach Road at 7.00 p.m.

<u>Present</u>: Cllrs B Paul, J Harris, R Simcox, G Macgregor, A Fielding, R Wilkie and A Newton. Apologies received from Cllr C Smith.

Apologies for absence also received from County Cllr S Manion and District Cllr K Morris.

Following issues raised during Public Question Time:-

Mrs Patricia O'Reilly – stated that Chapel Lane Pond is currently an "eyesore" and relies on few adjacent residents to keep it in some sort of order – asked if PC could do anything more. Cllr Paul advised that ths was to be discussed under later agenda item.

Peter Wells advised if footpath ER42 could be reported as there are currently pieces of metal sticking up from some of the steps. Advised that there is a large tree leaning over at the back of his property – reported before. Ownership of this part of the land in unsure but it was agreed this would be investigated.

Jim Stone asked if anything could be done about the parking in Reach Road and opposite Vicarage Lane, with cars now parking on the pavement. Agreed that PCSO be asked to look at this but it was felt that as other car parking is not restricted, there is little that can be done.

Viv Verren – asked that any proposed traffic survey previously discussed for the High Street, include Reach Road. This will be discussed with Steve Manion.

Cllr Paul advised she had spoken to Mr Phil Bean at Cloisters in Chapel Lane who had expressed a willingness to undertake the role of Pond Warden for Chapel Lane Pond, with the help of a group of volunteers. Cllr Paul agreed to be liaison point on the PC. Agreed that Council would pay for a pair of waders for Mr Bean.

IT WAS RESOLVED to accept quotation from D A Tree Surgeons in the sum of £865 for Clerk to arrange tree works to be undertaken at Chapel Lane Pond – they will need access via Cloisters which has been agreed.

15. Reports from Councillors

• Cllr Paul proposed that the Parish Council undertake to provide refreshments (tea and cake) after the Dover Patrol Service on 16th July with Clerk to first investigate | Clerk to deal how many persons are likely to attend before confirming. Clerk advised she did not feel this was best practice given the cost of a similar event two or three years ago.

Cllr Paul advised that on 6th September at 1.30pm the Bowls Club is arranging a game with the Chelsea Pensioners – she asked that Clerk write to Nigel Claringbould seeking permission for vehicles for bowlers on his land at Townsend Clerk to deal Farm and also to DDC seeking permission for the coach to drop off the Chelsea Pensioners in housing area opposite the pavilion.

Following request from Graham Wilson re Garden Safari, Parish Council had agreed that the Madge Field could be used to erect a ticket sales gazebo. Despite approaches to the Bay Trust which had allowed use of their land previously, this had received a negative response. Clerk asked to write to Mr Wilson asking that organisers give further thought to the question of parking for this event.

- Cllr Paula advised she had met with a Mr Kensington Laverne who is conducting a photographic record of local sites.
- Cllr Fielding had spoken with Cricket Club and it is felt that greater coverage by CCTV is needed for the King George V Field/Pavilion. Re the Alexander Pavilion, it would be difficult to have use of a wi-fi link from neighbouring residential property but it may be that if new CCTV equipment bought for KGV Pavilion, the old unit may be able to be re-used at other site. He will have a formal conversation with the Cricket Club and obtain a quotation (this to be on agenda).

Cllr Fielding to take forward and Clerk to place on agenda

Cllr Harris reported re present position on proposed bus shelter at Nelson Park. she has been liaising with John Pugh and also Dan Bruce at KCC. Formal permission would need to be sought from Kent Highways and any shelter would have to meet current disability regulations, and have space for a wheelchair to get off/on the bus, together with providing a dropped kerb (this may have to also be put in place on the shelter at the other side of the road. It is possible that some financial help may be available from KCC. First step is for Highways determination search to be undertaken. Has sought a quote from Queensberry Shelters who KCC have felt to be reliable in the past.

Cllr Harris to continue to take forward

Cllr Simcox advised there had been a problem with off-roaders in the Valley recently – apparently Police have been seen in the area. Clerk was asked to write to Chief Constable stressing that this sort of behaviour is criminal rather than civil when reporting using 101 contact number. Question raised as to whether PCSO was aware.
